COMES NOW Petitioner, by and through their attorney, Michael A. Risley, and pursuant to 22 O.S. §18/19, moves this Court to expunge the records below. This Amended Petition is submitted for the following reasons: Court requested full name in caption per Local Rules.

#### All Cases --

- 1. The harm to the privacy of the Petitioner or dangers of unwarranted adverse consequences outweigh the public and safety interests of the parties, to wit: Petitioner cannot advance in their career with a record.
- 2. Pursuant to the Oklahoma Pleading Code at 12 O.S. §2018, Petitioner may combine expungement requests for relief into one Petition, including requests which are subsequent to a predicate ruling:---
  - A. JOINDER OF CLAIMS. A party asserting a claim to relief as an original claim, counterclaim, crossclaim, or third-party claim, may join, either as independent or as alternate claims, as many claims, legal or equitable, as he has against an opposing party.
  - B. JOINDER OF REMEDIES; ... Whenever a claim is one heretofore cognizable only after another claim has been prosecuted to a conclusion, the two claims may be joined in a single action; but the court shall grant relief in that action only in accordance with the relative substantive rights of the parties.

The relevant category reads:

5. The person was arrested and no charges of any type, including charges for an offense different than that for which the person was originally arrested, are filed and the statute of limitations has expired or the prosecuting agency has declined to file charges;

WHEREFORE, as Petitioner is otherwise in compliance with 22 O.S. §18, Petitioner prays that this Court will order the aforementioned records expunged and provide Petitioner with all the rights provided by 22 O.S. §19.

Any such application may not be denied solely because of the Petitioner's refusal to disclose arrest and criminal records information that has been sealed;
- 2. FURTHERMORE AS TO THE 08/22/2009 ARREST, inspection of the records included in this Order may hereafter be permitted only upon Petition by the Petitioner, the Attorney General, or by the District Attorney, and released only to those persons and for such purposes named in such petition.
- 3. FURTHERMORE AS TO THE REMAINING RECORDS, records expunged herein shall be sealed to the public, but not to law enforcement agencies for law enforcement purposes. Records expunged herein shall be admissible in any subsequent criminal prosecution to prove the existence of a prior conviction or prior deferred judgment without the necessity of a court order requesting the unsealing of said records. Otherwise, inspection of the records included in this Order may hereafter be permitted only upon Petition by the Petitioner, the Attorney General, or by the District Attorney, and released only to those persons and for such purposes named in such petition. Any Pardon & Parole Board records expunged herein shall be sealed to the public but not to the Pardon & Parole Board.
- 4. **FINALLY**, the subject official actions shall be deemed never to have occurred, and the public, Petitioner, and all criminal justice agencies may properly reply, upon any inquiry in the matter, that no such action ever occurred and that no such record exists with respect to the Petitioner.
